## Blessed Sacrament Catholic Participating Tuition Rate

***To be considered for Catholic Tuition, a family must be registered for a minimum of one year prior to school registration. It is expected that those families who claim the Active Parishioner Grant will attend Mass regularly, participate in Sacraments, be active in parish ministries, and contribute financially to the support of their Parish. In addition, this form must be approved by the pastor, indicating that the family is in good standing and meets the requirements stated. If these criteria are not met, families will be expected to pay the Non-Participating/Non-Catholic tuition rate.***

If there is a financial hardship or other extenuating circumstances, you will need to make an appointment with Fr. Koetter and keep him informed of those circumstances. We are very aware that some families serve most generously both church and school, but have financial difficulties. As long as you communicate this clearly in advance to Fr. Koetter, and are faithfully present at Mass, you will receive the Catholic rate.

## Definition of a "Participating Catholic Family"

A person must be registered with the parish, attend Mass weekly and on Holy days, participate in the Sacraments, and take part in the activities of the parish. You must contribute in a recognizable way, such as online giving and through giving envelopes at Mass. If you are a registered member of Blessed Sacrament Catholic Church it is fully expected that your family attend weekly Mass, faithfully. Your attendance and contribution efforts are recognizable through weekly offertory (with envelope or check) as a means of mass attendance verification.

## Instructions

- 1) If you are a member of a Catholic Parish other than Blessed Sacrament Church, this form must be taken to your parish, completed, and returned directly to the SCHOOL. Your parish will then grant the subsidy and send it to Blessed Sacrament School on your behalf.
- 2) **If you are a returning school family or a member of Blessed Sacrament Church parish**, in good standing (active, contributing member), please complete this form and submit to parish office for approval. \*See above for the definition of "Participating Catholic". Please submit to the Blessed Sacrament Parish Office or email a copy to parish@mbschurch.org.
- 3) If you are a member of Blessed Sacrament Church, and it is determined that you are currently not in good standing, the **Catholic rate will not be applied**. You may contact the parish office to schedule an appointment to discuss with Fr. Koetter (912) 356-6980.
- 4) If you are a new school family, you must be a registered member of Blessed Sacrament Church parish for 1 year to receive in-parish tuition and must meet with Fr. Koetter. Please call the parish office to schedule a meeting (912) 356-6980.
- 5) Not applicable to non-Catholic families.
- 6) ***This approved form (signed by your Pastor) should be submitted every school year during re-enrollment to receive the Catholic rate.***
