Tuition Policy

The school reserves the right to use and enforce all legal remedies for failure to abide by the aforementioned standards. It may also preclude the admission of otherwise qualified candidates from the same family.

No student will be allowed to begin a new school year (August 1) or re-enroll until any remaining fees have been paid from the previous school year or a payment plan has been agreed to via FACTS tuition management program. Delinquent accounts are factors that will be considered in evaluating continued placement in the school.

The school has the right to dismiss a student if academic and/or discipline guidelines are not upheld. The school has the right to withhold grades, schedules, transcripts, and diplomas if financial commitments are not met. In extreme cases where financial commitments are not kept current or are ignored, the student may not be allowed to attend classes or participate in extracurricular activities.

- Blessed Sacrament School reserves the right to charge late fees, deny admission to final exams, restrict access to online grades, withhold report cards, transcripts, and/or records, and administratively suspend or withdraw students if payments are not received in a timely manner.
- All tuition collection issues are subject to appropriate credit reporting and collection agency follow-up. Parents assume responsibility for payment.
- Any student whose tuition is past due as of May 1 can not participate in graduation or end-of-year activities in addition to the penalties listed above.
- **If notice of withdrawal for the following school year is received prior to March 1**, you will be released from the continuous enrollment agreement including applicable tuition and fees.

- If notice of withdrawal is received from **March 1 - April 1**, you will be responsible for a \$250 cancellation fee and enrollment fee.
- If notice of withdrawal is received from **April 2 - May 1**, you will be responsible for a \$1,000 cancellation fee and enrollment fee.
- If notice of withdrawal is received from **May 2 - August 1**, you will be responsible for a \$2,000 cancellation and enrollment fee.
- If notice of withdrawal is received from **August 2 and November 21**, you will be responsible for the first semester's tuition.
- If notice of withdrawal is received **after November 21**, you will be responsible for a full year's tuition.

Student fees (Activity, Book, Security, Technology, Home & School Dues) are non-refundable. All incidental charges will be due upon withdrawal.

What if God has other plans for my family?

Exceptions can be allowed in exceptional circumstances that are beyond the family's control. Please partner with the school if you have any questions. We encourage families to communicate with the school in a timely and transparent manner.

In the event of withdrawal for any reason, all financial accounts must be current before report cards, transcripts, test results, and other official records are released.
